

**SECOND AMENDMENT TO AGREEMENT BETWEEN
TEMECULA COMMUNITY SERVICES DISTRICT AND VISIONONE, INC.**

THEATER TICKETING SOFTWARE AGREEMENT

THIS SECOND AMENDMENT is made and entered into as of **May 26, 2026** by and between the Temecula Community Services District, a community services district (hereinafter referred to as "City"), and **VisionOne, Inc.**, a **Corporation** (hereinafter referred to as "Consultant"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

1. This Amendment is made with the respect to the following facts and purposes:

a. On **July 1, 2021**, the City and Consultant entered into that certain Agreement entitled "Agreement for **Consultant Services**," in the amount of **\$120,000.00**.

b. On **June 11, 2024**, the City and Consultant entered into the **FIRST** Amendment to that Certain Agreement entitled "Agreement for Consultant Services" to extend the term of the Agreement to June 30, 2026 and increase the payment in the amount of \$80,000.00 for a total not to exceed amount of **\$200,000.00**.

The parties now desire to increase the payment in the amount of **\$10,000.00 for a total not to exceed amount of \$210,000** and to amend the Agreement as set forth in this Amendment.

2. Section **4** of the Agreement entitled "**PAYMENT**" at paragraph "a" is hereby amended to read as follows:

The City agrees to pay Consultant monthly, in accordance with the payment rates and schedules and terms set forth in Exhibit B, Payment Rates and Schedule, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms in Exhibit B, other than the payment rates and schedule of payment, are null and void. The **SECOND** Amendment amount shall not exceed **Ten Thousand Dollars and No Cents** (\$10,000.00), for a total Agreement amount of **Two Hundred Ten Thousand Dollars and No Cents** (\$210,000.00).

3. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.


