## SECOND AMENDMENT TO AGREEMENT BETWEEN CITY OF TEMECULA AND MIKE'S PRECISION WELDING, INC.

## WELDING MAINTENANCE SERVICES

THIS SECOND AMENDMENT is made and entered into as of January 23, 2024, by and between the City of Temecula, a municipal corporation (hereinafter referred to as "City"), and Mike's Precision Welding, Inc., a Corporation (hereinafter referred to as "Contractor"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

- 1. This Amendment is made with the respect to the following facts and purposes:
- a. On **July 28, 2022**, the City and Contractor entered into that certain Agreement entitled "Agreement for **Welding Maintenance Services**," in the amount of **\$60,000**.
- b. On **September 12, 2023**, the City and Contractor entered into the **First Amendment** to that certain Agreement entitled "Agreement for **Minor Maintenance Services**," to increase the payment in the amount of \$40,000.
- c. The parties now desire to increase the payment in the amount of \$50,000, and to amend the Agreement as set forth in this Amendment.
- 2. Section **3** of the Agreement entitled "**PAYMENT**" at paragraph "a" is hereby amended to read as follows:

The City agrees to pay Contractor monthly, in accordance with the payment rates and schedules and terms set forth in Exhibit B, Payment Rates and Schedule, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms in Exhibit B, other than the payment rates and schedule of payment, are null and void. The total amount of this Agreement shall not exceed **One Hundred Fifty Thousand Dollars (\$150,000)**.

3. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.
