FIRST AMENDMENT TO AGREEMENT BETWEEN CITY OF TEMECULA AND LIEBERT CASSIDY WHITMORE

SPECIAL ATTORNEY SERVICES

THIS FIRST AMENDMENT is made and entered into as of September 24, 2024 by and between the City of Temecula, a municipal corporation (hereinafter referred to as "City"), and Liebert Cassidy Whitmore an S Corporation (hereinafter referred to as "Consultant"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

- 1. This Amendment is made with the respect to the following facts and purposes:
- a. On **July 1, 2022**, the City and Consultant entered into that certain Agreement entitled "Agreement for **Special Attorney Services**.
- b. The parties now desire to extend the term of the agreement to **June 30**, **2025** and increase the payment in the amount not to exceed Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00), per fiscal year and to amend the Agreement as set forth in this Amendment.
- 2. Section 11 of the Agreement entitled "TERM" is hereby amended to read as follows:

"This Agreement shall remain and continue in effect until tasks herein are completed, but in no event later than **June 30, 2025** unless sooner terminated pursuant to the provisions of this Agreement.

3. Section **3** of the Agreement entitled "**FEES**, **COSTS**, **EXPENSES**" at paragraph "Other Expenses" is hereby amended to read as follows:

The City agrees to pay Consultant monthly, in accordance with the payment rates and schedules and terms set forth in the original agreement and Schedule II, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms other than the payment rates and schedule of payment, are null and void. The **FIRST** Amendment amount shall not exceed Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00), per fiscal year.

4. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.
