SUBJECT: Approve Specifications and Authorize the Solicitation of Construction Bids for the Americans with Disabilities Act (ADA) Transition Plan Implementation – ADA Curb Ramp Replacement Phase I, PW24-07

RECOMMENDATION: That the City Council:

1. Approve the specifications for the Americans with Disabilities Act (ADA) Transition Plan Implementation – ADA Curb Ramp Replacement Phase I, PW24-07; and
2. Authorize the Department of Public Works to solicit construction bids for the Americans with Disabilities Act (ADA) Transition Plan Implementation – ADA Curb Ramp Replacement Phase I, PW24-07; and
3. Make a finding that this project is exempt from California Environmental Quality Act (CEQA) per Article 19, Categorical Exemption, Section 15301, Existing Facilities, of the CEQA Guidelines.

BACKGROUND: As part of the Capital Improvement Program and Budget for Fiscal Year 2026-30, the City Council approved appropriations to support the implementation of the City's Americans with Disabilities Act (ADA) Transition Plan. This is an annual appropriation funded with CDBG and Measure S funds. This project will reconstruct approximately 40 curb ramps to meet current ADA standards. The ramps selected for current funds are located throughout the Harveston development and on Ynez Road.

This project is exempt from the California Environmental Quality Act (CEQA) requirements pursuant to Article 19, Categorical Exemption, Section 15301, Existing Facilities, of the CEQA Guidelines. Section 15301 states that the repair and maintenance of existing highways, streets, and gutters are Class 1 activities, which are exempt from CEQA.

Project specifications are complete, and the project is ready to be advertised for construction bids. The contract documents are available for review in the office of the Director of Public Works.

The Engineer's Construction Cost Estimate for the Project is \$350,000. Construction duration is estimated to be Fifty (50) working days, which is approximately two and a half (2 1/2) months.

FISCAL IMPACT: The Americans with Disabilities Act (ADA) Transition Plan Implementation – ADA Curb Ramp Replacement Phase I, PW24-07, is identified in the Fiscal Year 2026-30 Capital Improvement Program (CIP) Budget utilizing Community Development Block Grant (CDBG) and Measure S funds. Adequate funds are available in the project account to construct the project.
