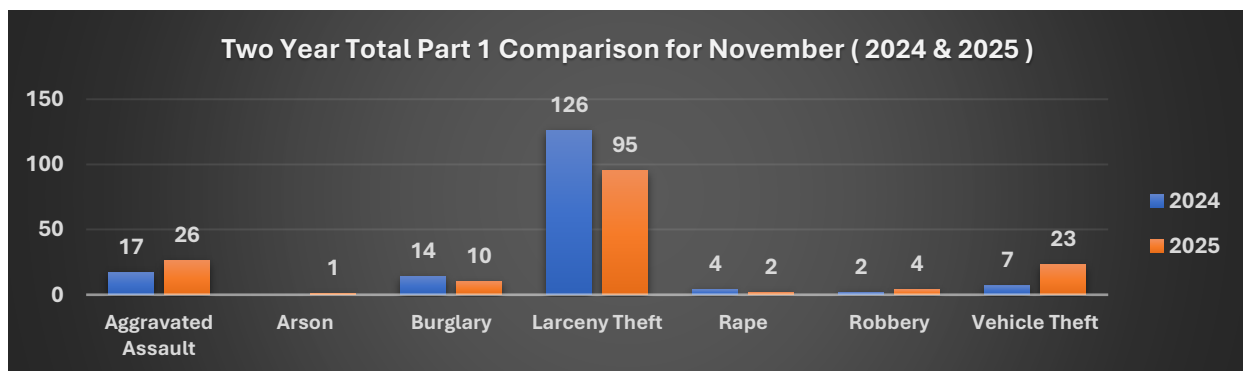
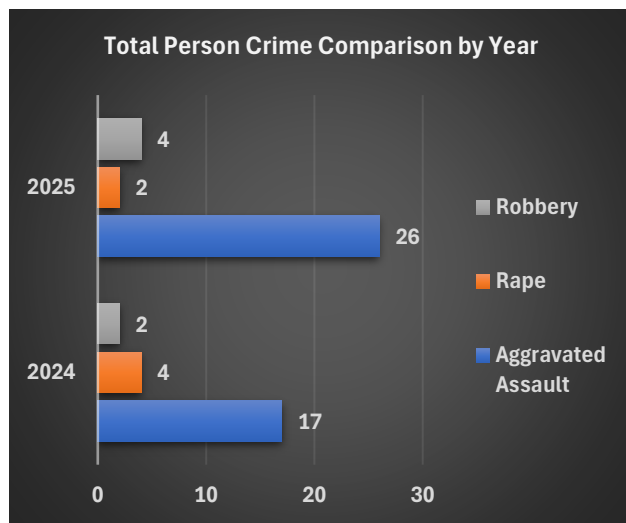
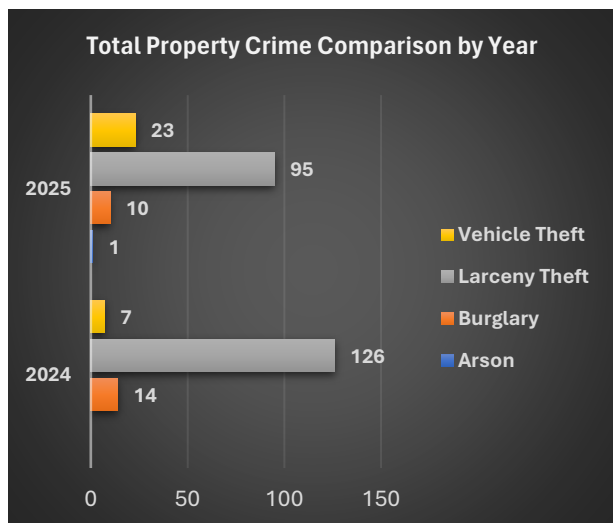

Two Year Data Comparison For November (2024 & 2025)



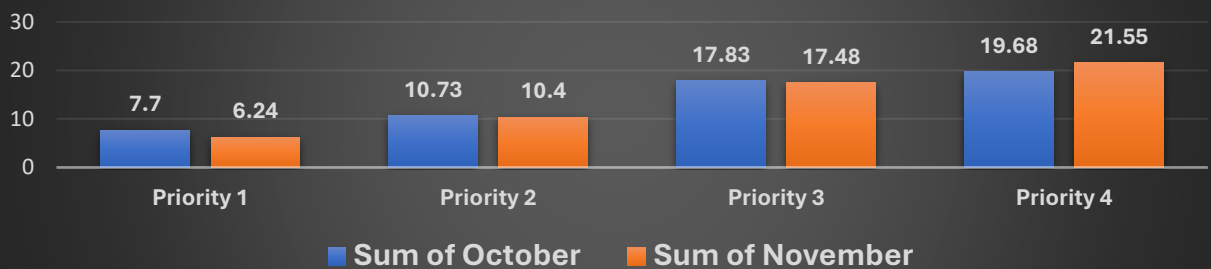

Priority 1: Involved circumstances that pose, or did pose in the immediate past, a clearly defined threat to human life or property, and which involve a high level of violence or the potential for serious injury.

Priority 2: Involve circumstances of an urgent, but not life-threatening nature. They are generally disturbances with a potential for violence, minor assaults and batteries, etc.

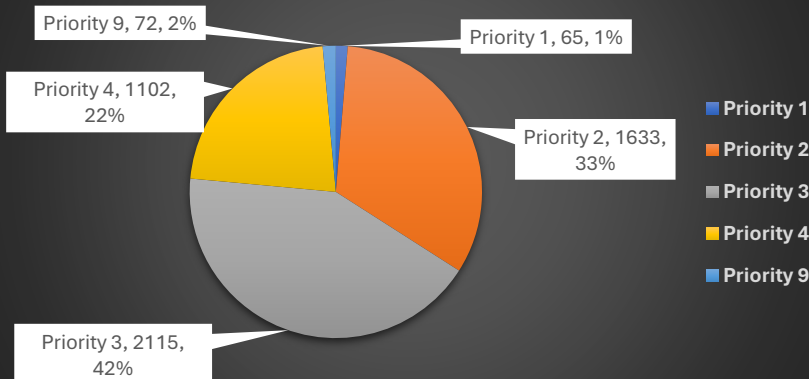
Priority 3: Involve circumstances that are neither urgent nor life-threatening.

Priority 4: Except for a few felonies, most past incidents are classified as Priority 4.

Priority 9: Those calls meeting the criteria for processing by the Telephone Report Unit (TRU).

Notable Cases

SW253270031 - Investigators conducted follow-up on a high-risk runaway juvenile case. Information was developed that indicated the juvenile was a victim of human trafficking and commercial sexual exploitation in the Los Angeles area. Investigations personnel developed evidence with legal process to the social media companies, community video collection, and follow-up interviews with friends of the victim. Investigations personnel worked with the Riverside County Anti-Human Trafficking task force. **The victim was successfully rescued in the Long Beach area.** Case agents: Cpl. Au, Dep. Risen, Inv. Roberge, and Inv. Riddle)

TE253240059 - Investigators conducted follow-up on a felony domestic violence case. The victim was treated at a local hospital for head trauma and strangulation injuries. The suspect fled the scene. Investigator Roberge worked with Riverside County DA Gang Impact Team, Special Enforcement Bureau K9, and patrol personnel to successfully apprehend the suspect. **The suspect was arrested, and bail enhancement and emergency protective order were granted.** Case agent: Inv. Roberge

TE253140173 - Investigators were called out to assist patrol with an assault with a deadly weapon case in the Sommers Bend community. On November 10, 2025, at 10:41 p.m., deputies for the Southwest Sheriff's Station were dispatched to the 32000 block of Daybrook Terrace, Temecula, regarding the brandishing of a firearm. Upon arrival, deputies spoke with the reporting party, who advised his 17-year-old son had been stopped by a subject in the roadway while driving in a residential neighborhood. Deputies were also told that the subject who stopped him displayed a badge and ordered the juvenile out of the vehicle at gunpoint. The juvenile complied and was ultimately released to his parents, who reported the incident to law enforcement.

During the investigation, the suspect was identified as Gerardo Rodriguez, a 45-year-old resident of Temecula. Rodriguez was contacted at his residence and taken into custody without incident. A search warrant was authored and served at Rodriguez's residence, where evidence related to the investigation was collected. **Rodriguez was booked into the Cois Byrd Detention Center for assault with a deadly weapon, child endangerment, and assault by a public officer.** (Case agents: Inv. Morris & Inv. Mills)

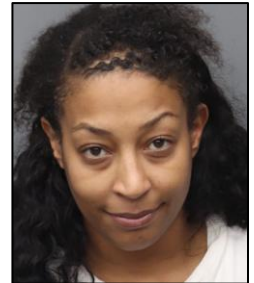

TE253180068 - Corporal Au investigated a violation of sex offender requirements. A local sex registrant, Anthony Gonzalez, was in violation of registration requirements and had a felony warrant for probation violation. **Cpl Au arrested and booked Gonzalez into custody at Cois Byrd Detention Center. (Case agent: Cpl. Au)**

SW253080002 - Inv. Roberge and Deputy Risen investigated a physical abuse of a child case involving a 10-year old boy. Evidence was developed that the child's estranged mother abused the victim. The mother was attempting to take the child out of state and avoid law enforcement & Children Services Division. The child was placed into safe custody with a family member. **The suspect, Airyssa Shannon, was arrested for felony child abuse charges. (Case agents: Inv. Roberge & Deputy Risen)**

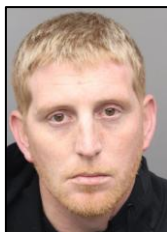

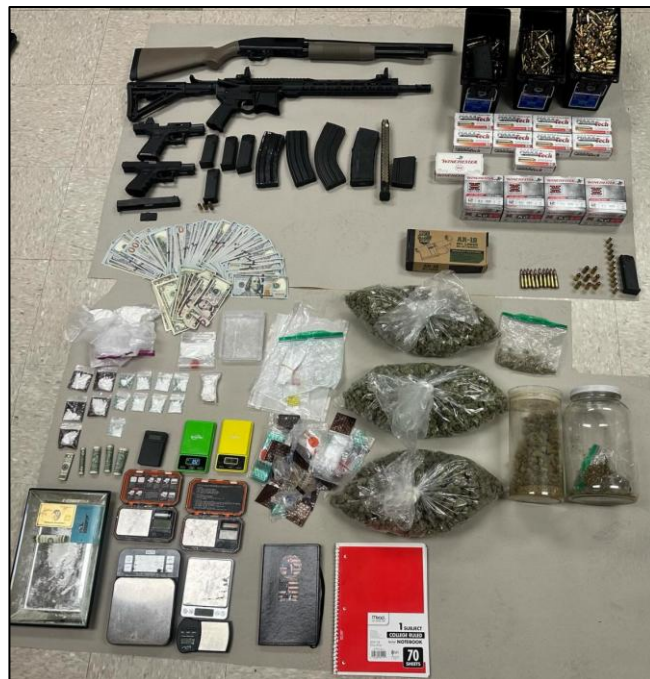

On 11/19 SET stopped a vehicle at Pechanga Pkwy. The driver, June Alejo, was on parole, and there were 2 additional occupants. A compliance check was conducted. Deputies located fentanyl on Novodoczky. Deputies found methamphetamine inside Alejo's purse. **Novodoczky & Alejo were arrested for multiple narcotics charges. Agajanian was arrested for being under the influence of a controlled substance.**

SET received information that Ryan Brock, a Temecula resident was selling cocaine and fentanyl. Through surveillance, SET observed Ryan meet with multiple subjects for short periods in various locations throughout the city. He was also seen entering a business located at 28364 Vincent Moraga #C. There was no record of a business operating, and a for lease sign was posted out front. A search warrant was authored for Ryan, his vehicle, and residence. On 11/25 SET conducted a traffic stop on Ryan pursuant to the warrant. They located 14 baggies with cocaine packaged for sale, a scale, and cash. His roommate, Michael Barton, was a passenger. At the residence deputies located cash, an assault rifle, a 12-gauge shotgun, 2 handguns, a large amount of ammunition, and over 3lbs of marijuana. **Ryan was arrested for multiple narcotics related charges.**

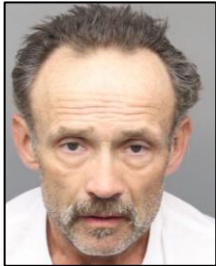

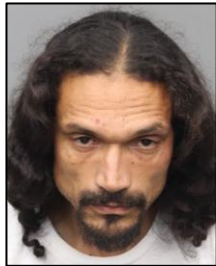

Deputies arrived and the suspects, **Darren Tokar & Avery Dunn** **surrendered and were arrested for burglary.**

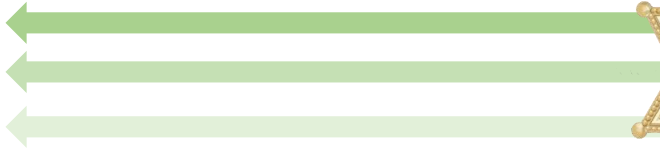

On 11/01, Patrol responded to an unknown trouble call at the 41000 block of Temecula Center Drive. Deputies arrived and detained a male and female subject inside a vehicle. The male subject, identified as **Carlos Menjivar**, had a Nitrous Oxide (Laughing gas) tank inside the vehicle and was inhaling it from a balloon. Deputies noticed a gun magazine in the center console of the vehicle. Deputies also located a loaded Glock 17 firearm, 3 magazines, a Nitrous Oxide tank, and psilocybin mushrooms. **Menjivar was arrested for carrying a loaded firearm, possession of nitrous oxide, possession of narcotics, and being under the influence of a controlled substance.**

On 11/02, Deputies received an Automated License Plate Reader alert, referencing a stolen vehicle on Temecula Pkwy & Butterfield Stage Rd. The report named a suspect, **Enrique Lemus**, wanted armed & dangerous. Deputies located the vehicle and conducted a felony stop. The driver, **David Beverly**, surrendered. The passenger crawled to the driver's seat and fled the scene. A pursuit ensued, and deputies were unable to locate the vehicle. **Beverly was arrested for possession of a stolen vehicle. Deputies will conduct a follow-up reference Lemus.**
