

Proposal:	Home Product Review Application for Planning Area 12 of the Roripaugh Ranch Specific Plan to allow for five (5) unique detached single-family plans with four (4) architectural styles consisting of 104 lots and a Minor Exception Application to allow for a reduction of the minimum rear yard setback on five (5) lots (lots 23, 25, 73, 91, & 95) from 10'-0" down to a minimum of 8'-6" within Planning Area 12.
