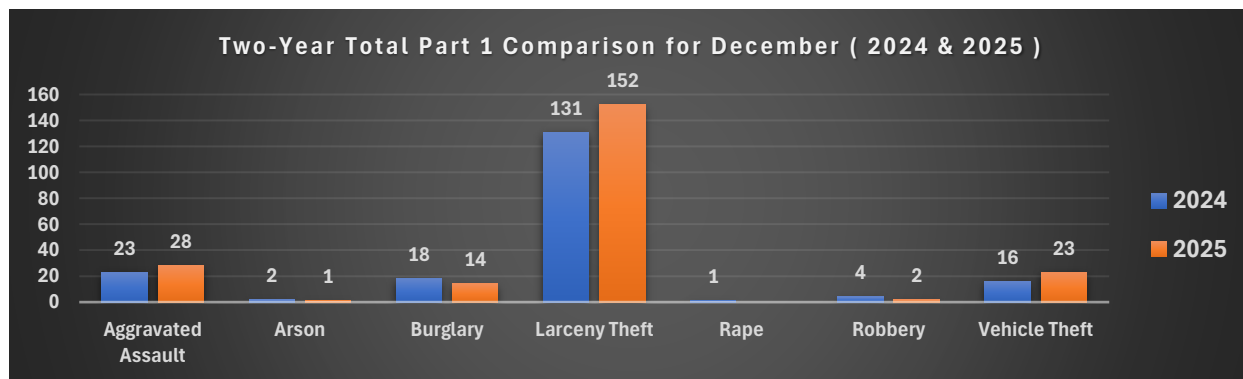
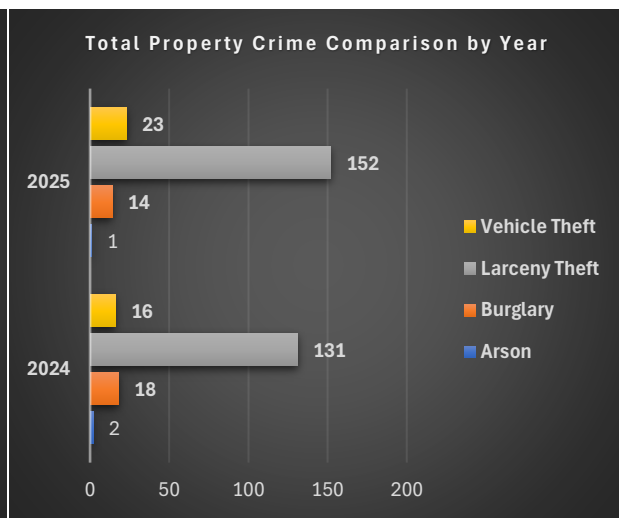
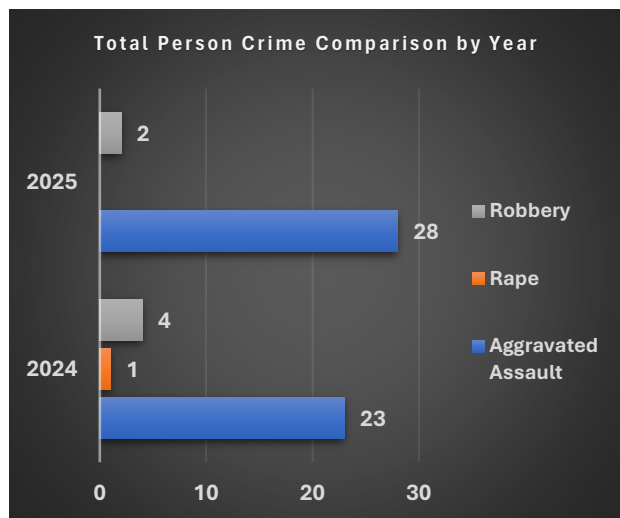

## Two Year Data Comparison For December ( 2024 & 2025 )



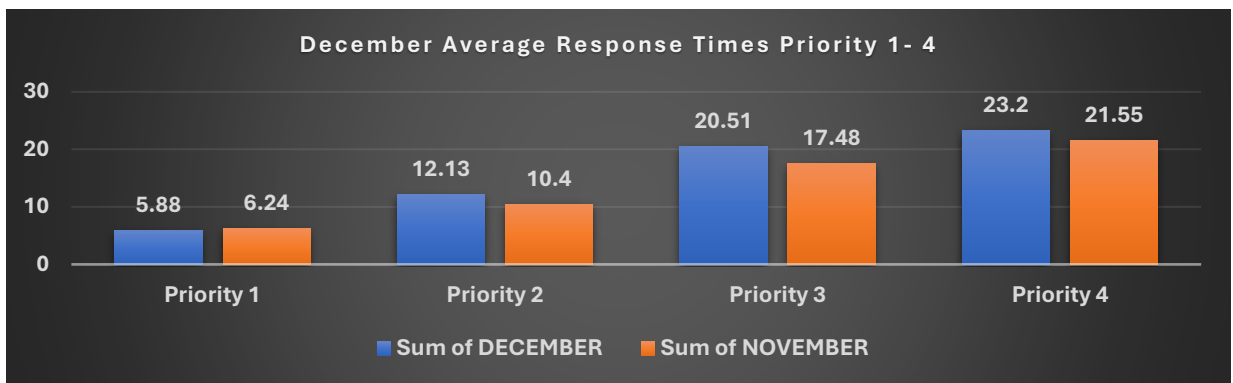

**Priority 1:** Involved circumstances that pose, or did pose in the immediate past, a clearly defined threat to human life or property, and which involve a high level of violence or the potential for serious injury.

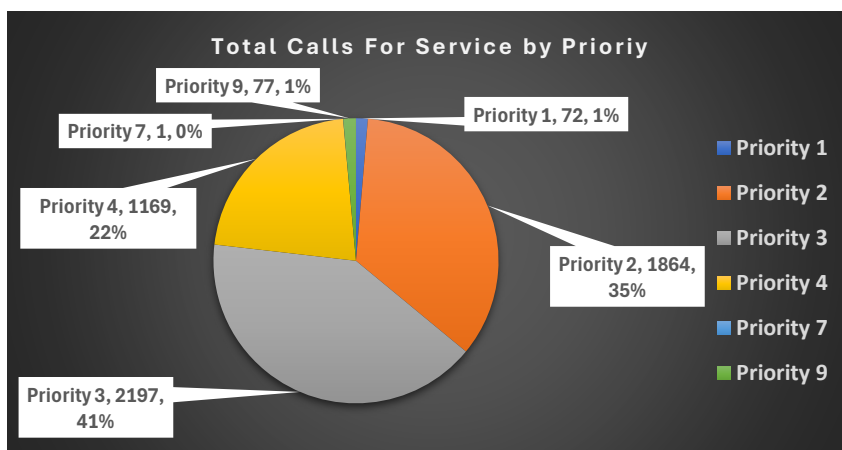
**Priority 2:** Involve circumstances of an urgent, but not life-threatening nature. They are generally disturbances with a potential for violence, minor assaults and batteries, etc.

**Priority 3:** Involve circumstances that are neither urgent nor life-threatening.

**Priority 4:** Except for a few felonies, most past incidents are classified as Priority 4.

**Priority 9:** Those calls meeting the criteria for processing by the Telephone Report Unit ( TRU).

On 12/05, SET was patrolling the area of Rancho California and Margarita Rd. in reference to ongoing narcotics activity. Deputy Davis initiated a traffic enforcement stop on an older Honda Accord. The driver failed to stop, and a pursuit ensued. The vehicle eventually stopped, and the driver ran from the vehicle. Additional occupants were detained. One occupant was on formal probation, and the vehicle was searched. Deputies eventually located the driver. Inside the vehicle, a large knife and methamphetamine were located. **They were arrested for various HS charges, probation violations, and a felony warrant.**

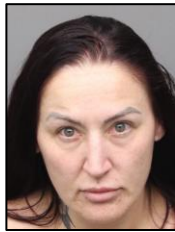
On 12/16, SET conducted a traffic stop on a vehicle, and the driver, Dale Thomas, was found in possession of a double-edged, spring-loaded knife. He was out on bail for selling and transporting methamphetamine. A K9 narcotics detection dog was requested and conducted a sniff of the vehicle, which resulted in a positive alert for the presence of narcotics. A search of the vehicle was conducted, and deputies located over a half pound of methamphetamine along with numerous baggies. **He was arrested for multiple HS charges.**



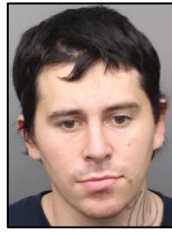

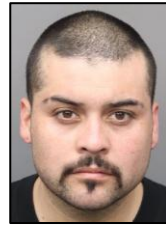

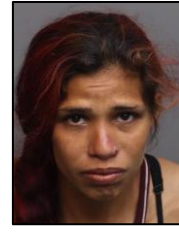

SET received information that a residence, located in the 41000 block of Via Halcon, was involved in ongoing narcotics activity, including frequent short-term traffic. This is consistent with drug users coming and going throughout the day, and possible sales occurring at the location. On 12/05, an operation involving UC and takedown units was conducted at the residence. They attempted to stop a vehicle that left the residence, but the driver fled, and a pursuit ensued. They detained the occupants of the vehicle and recovered narcotics. **All were arrested for drug-related charges. A search warrant for the residence also occurred, arresting several known drug users.**

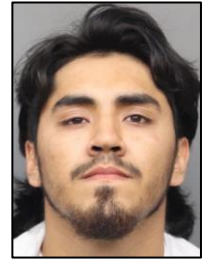


# TRAFFIC TEAM

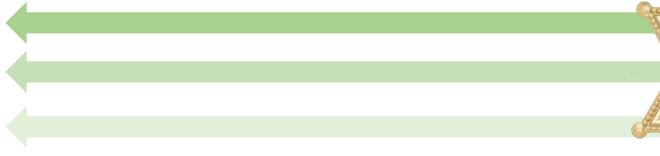

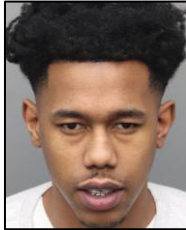

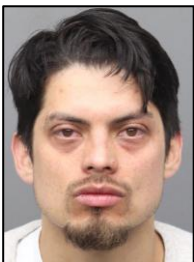

On 12/10, deputies responded to a vehicle burglary at the See's Candy store. The victim had just withdrawn money from a bank in Murrieta before driving to Temecula. Witnesses described the suspect vehicle. Using FLOCK, a license plate was located. Deputies checked video from the bank and located the same vehicle in the bank parking lot. The vehicle information was shared with other agencies. Fontana PD located the vehicle at a Bank of America parking lot and detained all three occupants. They matched the description, and they found similar denominations of money taken in the burglary. **All were arrested for burglary charges.**

On 12/19, a general broadcast of a subject in a stolen vehicle was in the Temecula area. A firearm was believed to be in the vehicle. GTF initiated a stop, but the suspect, Diamond Momosea, evaded at a high rate of speed. The suspect collided with numerous cars near the intersection of Jefferson Ave. & Winchester Rd. The suspect drove to the Temecula Mall, where he exited the vehicle and ran into the Round 1 Arcade. Deputies evacuated patrons, and the suspect was located and taken into custody. The suspect discarded the firearm into a dumpster moments before he was taken into custody. **The 9MM Glock was recovered, and he was arrested for felony evading and firearm possession.**

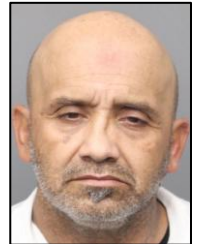

On 12/31, deputies responded to a vehicle burglary at the EOS Fitness. The victim left her purse in her vehicle.
