5. Mira Loma Road North of Rancho Vista Road

damaged electrical service on Mira Loma Drive North of Rancho Vista Road. Lane delineation will be implemented around the work zone. Working hours are 8:30 AM to

6. Nicolas Detour

Project: Nicolas Road Extension

Status: Nicolas Road will be closed starting at Leifer / Calle Medusa. Traffic will detour along

7. Santa Gertrudis Creek Trail at Margarita Road
