It is with great honor that I request that the Temecula City Council consider that the new "Biking/Walking trail" running along Diaz Road be named after former resident and local hero, Staff Sgt. Louis F. Cardin U. S. Marine Corps.

Louis "Louie" Cardin was born on April 27, 1988 in Riverside, California, grew up in Anza, Aguanga, Temecula, and graduated from Chaparral High School, Temecula in 2006.

He was a decorated Marine who served in the U.S. Marine Corps. He joined the Marines in June 2006, serving as a field artilleryman.

Throughout Louie's 10-years in the Marine Corps, his service included deployments to Iraq in 2007 and three deployments to Afghanistan. He was stationed at Camp Pendleton, California, and Camp Lejeune, North Carolina.

Louis F. Cardin was tragically killed on March 19, 2016, in northern Iraq. He was supporting Operation Inherent Resolve, the U.S. military's campaign against ISIS. Cardin, assigned to the 2nd Battalion, 6th Marine Regiment, 26th Marine Expeditionary Unit, was killed during a rocket attack by ISIS militants on a coalition base in Makhmur. Eight other Marines were injured in the attack.

The attack occurred when ISIS fired rockets at the base where Cardin and other Marines were positioned. U.S. counter-battery radar provided some warning, and the Marines ran for cover when sirens sounded. One rocket missed, but another hit near Cardin, causing fatal injuries to his chest. He was the second combat fatality in Iraq during Operation Inherent Resolve. Louie was 27 years old.

Staff Sgt. Cardin was remembered and honored for his service and sacrifice. A memorial ceremony was held for him at the Protestant Chapel at Marine Corps Base Camp Lejeune, North Carolina, on July 14, 2016. He is survived by his parents and six siblings
