SUBJECT: Approve Purchase of One Altec AT37G Boom Truck from Altec Industries, Inc. for Public Works Traffic Maintenance

RECOMMENDATION: That the City Council approve the purchase of one Altec AT37G Boom Truck from Altec Industries, Inc. utilizing Sourcewell contract #110421-ALT for a total amount of \$189,915.78.

BACKGROUND: The City of Temecula Public Works Department is responsible for maintaining traffic signals, streetlights, and other essential infrastructure to ensure safe and efficient transportation throughout the City. To support these operations, specialized vehicles such as boom trucks is required for tasks involving elevated work, including signal maintenance, lighting repairs, and installation of traffic control devices.

The existing boom truck in the Public Works Traffic Maintenance fleet has reached the end of its service life and is no longer cost-effective to maintain or suitable for continued deployment. Aging equipment increases the risk of mechanical failure, reduces operational efficiency, and can compromise worker safety. Timely replacement of this essential vehicle is critical to maintaining reliable traffic operations and minimizing service disruptions.

To obtain the best value and expedite the procurement process, staff recommends purchasing the replacement boom truck using the pricing and terms established through Sourcewell's competitively awarded contract #110421-ALT with Altec Industries, Inc. Sourcewell conducted a formal, competitive solicitation for current-production Altec boom trucks and awarded a cooperative purchasing agreement to Altec Industries, Inc. This approach ensures compliance with municipal purchasing requirements while leveraging pricing negotiated through a recent public bidding process.

The attached quote from Altec Industries, Inc. provides a total purchase price of **\$189,915.78**, inclusive of all applicable taxes and fees. The Altec AT37G Boom Truck is specifically designed for utility and traffic maintenance applications, offering features that enhance safety, reliability, and operational efficiency. The purchase includes standard manufacturer warranties covering parts and workmanship.

The procurement method is authorized under **Temecula Municipal Code §3.28.290(E)**, which provides an exception to formal bidding when “any agreement involving acquisition of supplies, equipment or services is entered into with another governmental entity.” By utilizing the pricing from Sourcewell’s competitively awarded contract, the City secures high-quality equipment while reducing staff time and administrative costs associated with issuing a separate solicitation. This approach maintains transparency, compliance with local purchasing policies, and ensure timely replacement of essential fleet equipment critical to the continued delivery of public services.

FISCAL IMPACT: The purchase of one (1) heavy-duty truck vehicles is included, and adequate funds are available in the Fiscal Year 2025-26 Annual Operating Budget from the Vehicle Replacement Fund.
