

**FOURTH AMENDMENT TO AGREEMENT BETWEEN
TEMECULA COMMUNITY SERVICES DISTRICT AND TRANSPORTATION CHARTER
SERVICES, INC.**

TRANSPORTATION SERVICES

THIS FOURTH AMENDMENT is made and entered into as of **May 12, 2026** by and between the Temecula Community Services District, a community services district (hereinafter referred to as "City"), and **Transportation Charter Services, Inc., a Corporation** (hereinafter referred to as "Contractor"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

1. This Amendment is made with the respect to the following facts and purposes:

a. On **March 21, 2022**, the City and Contractor entered into that certain Agreement entitled "NON-EXCLUSIVE SERVICES AGREEMENT BETWEEN TEMECULA COMMUNITY SERVICES DISTRICT AND TRANSPORTATION CHARTER SERVICES," in the amount of **\$60,000.00**.

b. On **August 21, 2023**, the City and Contractor entered into the **First Amendment** to that certain Agreement entitled "NON-EXCLUSIVE SERVICES AGREEMENT BETWEEN TEMECULA COMMUNITY SERVICES DISTRICT AND TRANSPORTATION CHARTER SERVICES," to increase the payment to the amount of **\$100,000.00**.

c. On **August 13, 2024**, the City and Contractor entered into the **Second Amendment]** to that certain Agreement entitled "NON-EXCLUSIVE SERVICES AGREEMENT BETWEEN TEMECULA COMMUNITY SERVICES DISTRICT AND TRANSPORTATION CHARTER SERVICES," to increase the payment to the amount of **\$200,000.00**.

d. On **March 25, 2025**, the City and Contractor entered into the **Third Amendment** to that certain Agreement entitled "NON-EXCLUSIVE SERVICES AGREEMENT BETWEEN TEMECULA COMMUNITY SERVICES DISTRICT AND TRANSPORTATION CHARTER SERVICES," to extend the term of the agreement to March 21, 2026.

The parties now desire to extend the term of the agreement to **March 21, 2027** and to amend the Agreement as set forth in this Amendment.

2. Section 1 of the Agreement entitled "**TERM**" is hereby amended to read as follows:

"This Agreement shall remain and continue in effect until tasks herein are completed, but in no event later than **March 21, 2027** unless sooner terminated pursuant to the provisions of this Agreement.

3. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.




