

**SECOND AMENDMENT TO AGREEMENT BETWEEN
CITY OF TEMECULA AND NIEVES LANDSCAPE, INC.**

LANDSCAPE MAINTENANCE

THIS SECOND AMENDMENT is made and entered into as of **May 24, 2022** by and between the City of Temecula , a municipal corporation (hereinafter referred to as "City"), and **Nieves Landscape, Inc., a Corporation** (hereinafter referred to as "Contractor"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

1. This Amendment is made with the respect to the following facts and purposes:
 - a. On **April 27, 2021**, the City and Contractor entered into that certain Agreement entitled "Agreement for **Minor Maintenance Services**," in the amount of **\$1,757,796.00**.
 - b. On **August 10, 2021**, the City approved contingency for extra work in the amount of **\$351,559.20**
 - c. On **October 26, 2021**, the City and Contractor entered into the **First Amendment** to that certain Agreement entitled "Agreement for **Minor Maintenance Services**," to add scope of work and increase the payment in the amount of **\$607,225.60**.
 - d. The parties now desire to extend the term of the agreement to **June 30, 2023**, increase the payment in the amount of **\$2,748,693.48**, and to amend the Agreement as set forth in this Amendment.
2. Section **1** of the Agreement entitled "**TERM**" is hereby amended to read as follows:

This Agreement shall remain and continue in effect until tasks herein are completed, but in no event later than **June 30, 2023** unless sooner terminated pursuant to the provisions of this Agreement.
3. Section **3** of the Agreement entitled "**PAYMENT**" at paragraph "a" is hereby amended to read as follows:

The City agrees to pay Contractor monthly, in accordance with the payment rates and schedules and terms set forth in Exhibit B, Payment Rates and Schedule, attached hereto and incorporated herein by this reference as though set forth in full, based upon actual time spent on the above tasks. Any terms in Exhibit B, other than the payment rates and schedule of payment, are null and void. This amount shall not exceed **Five Million, Four Hundred Sixty-Five Thousand, Two Hundred Seventy-Four Dollars and Twenty-Eight Cents (\$5,465,274.28)** for the total term of this agreement, unless additional payment is approved as provided in this agreement.

4. Exhibit **B** to the Agreement is hereby amended by adding thereto the items set forth on Attachment "A" to this Amendment, which is attached hereto and incorporated herein as though set forth in full.

5. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect.


