A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TEMECULA COMMUNITY SERVICES DISTRICT OF THE CITY OF TEMECULA, INITIATING PROCEEDINGS TO ANNEX PROPERTY TO SERVICE LEVEL B FOR FISCAL YEAR 2023-24

WHEREAS, the Board of Directors (the "Board") of the Temecula Community Services District (the "District") of the City of Temecula desires to undertake proceedings pursuant to the provisions of the Landscape and Lighting Act of 1972, Part 2, Division 15 of the California Streets and Highways Code (commencing with Section 22500) (hereafter referred to as the "Act"), to annex certain property, to Service Level B of the District (the "Assessment District") for the purpose of funding Residential Street Lighting; and

**WHEREAS**, the Board of Directors has retained Webb Municipal Finance, LLC. for the purpose of preparing and filing the Engineer's Report and assisting in the public hearing and formation process of the proposed annexation.

**NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of Directors of the Temecula Community Services District of the City of Temecula, California as follows:

## **Section 1.** Recitals

That the Recitals set forth above are true and correct.

### Section 2. Engineer's Report

The Board of Directors hereby orders Webb Municipal Finance, LLC. to prepare and file with the Clerk of the Board the Engineer's Report (the "Report") concerning the annexation of property, to the Assessment District in accordance with the Act and the laws of the State of California.

### Section 3. Improvements

The improvements shall include the maintenance and servicing of residential street lighting.

### Section 4. Severability

That the Board of Directors declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of the Resolution as hereby adopted shall remain in full force and effect
