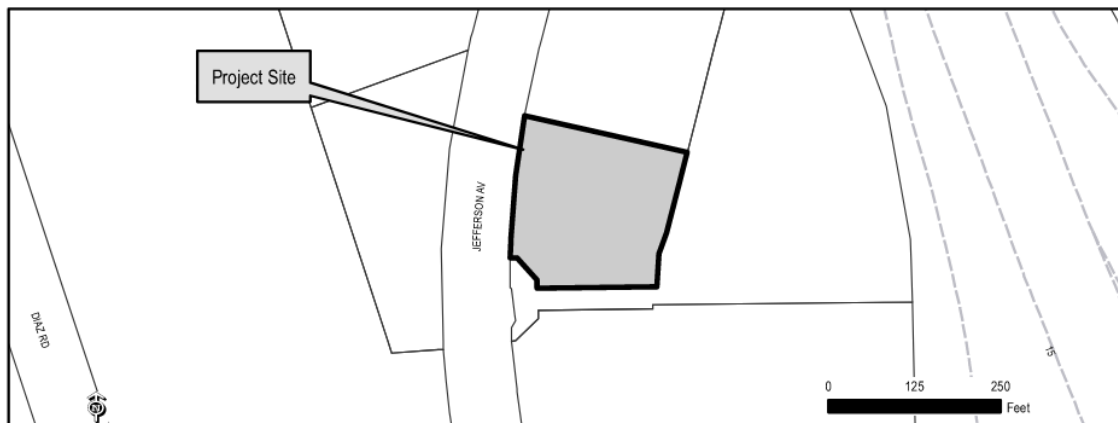




# Notice of Public Hearing

**A PUBLIC HEARING** has been scheduled before the City of Temecula **PLANNING COMMISSION** to consider the matter described below:

- CASE NO:** PA16-0966      **APPLICANT:** Anthony Yang, on Behalf of Hilton Garden Inn
- PROPOSAL:** A Conditional Use Permit for Hilton Garden Inn to obtain a Type 70 ABC License (On Sale General – Restrictive). The site is located approximately 900 feet north of Rancho California Road on Jefferson Avenue.
- ENVIRONMENTAL:** In accordance with the California Environmental Quality Act (CEQA), the proposed project is exempt from further environmental review and a Notice of Exemption will be considered for adoption by the Planning Commission in compliance with State CEQA Guidelines Section 15301, Class 1, Existing Facilities and Section 15601(b)(3) as it can be seen with certainty that the proposed project will not have a significant effect on the environment.

In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Planning Commission shall be limited to those issues raised at the hearing or in written correspondence delivered to the City Clerk at, or prior to, the public hearing described in this notice.
