## **RESOLUTION NO. 2021-**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMECULA TO APPROVE THE SOLID WASTE AND RECYCLING RATES FOR COMMERCIAL CUSTOMERS FOR FISCAL YEAR 2021-22

THE CITY COUNCIL OF THE CITY OF TEMECULA DOES HEREBY RESOLVE AS FOLLOWS:

- A. The City of Temecula and CR&R Incorporated entered into an exclusive solid waste Franchise Agreement on May 28, 1991, as amended on August 27, 1996, June 24, 1997, July 25, 2000, June 13, 2006, October 27, 2015, and November 28, 2017 ("Franchise Agreement"), for the collection, transportation, recycling, composting, and disposal of solid waste and construction debris and for providing temporary bin/roll off services in the City.
- B. The Franchise Agreement specifically provides for and stipulates the conditions upon which rates may be adjusted on an annual basis at each July 1<sup>st</sup>, specifically the data from the Bureau of Labor Statistics designated change in Consumer Price Index ("CPI") from the previous calendar year, and changes to the Riverside County Department of Waste Resources landfill disposal rates.
- C. Based on the formula set forth in the Franchise Agreement, the following applicable indices have been used to calculate the rate adjustments for Fiscal Year 2021-22:
  - 1. The CPI from January 2020 through December 2020 has increased by .78% and will be applied to the Fiscal Year 2021-22 rate adjustments.
  - 2. The Riverside County Department of Waste Resources landfill tipping fee has increased 2.25% and will be applied to the Fiscal Year 2021-22 rate adjustments.
- D. Based on the formula set forth in the Franchise Agreement and the findings set forth above, the City Council hereby approves the maximum solid waste and recycling rates for Fiscal Year 2021-22 as shown in "Exhibit D" attached hereto and incorporated herein as though set forth in full. for Fiscal Year 2021-22, as set forth in the Franchise Agreement.
  - E. The City Clerk shall certify to the passage and adoption of the resolution.
